REOUIREMENTS FOR ERASMUS, SICUE OR BILATERAL EXCHANGE STUDENTS WHO ARE CARRYING OUT A MOBILITY IN THE DEGREE IN MEDICINE AT THE UNIVERSITY OF SANTIAGO DE COMPOSTELA-USC

General requirements

• The study program for Medicine degree can be consulted at the following link:

- The exchange stay must be adjusted to the USC academic calendar.
- The following subjects cannot be included in the learning agreement:
 - ✓ The optional subjects G2051347 External internship after school time period I, G2051447 External internship after school time period II and G2051547 External internship after school time period III.
 - ✓ G2051628 Undergraduate dissertation.

Requirements for taking clinical practices subjects:

- All clinical practices are carried out at the University Hospital Complex of Santiago de Compostela (SPAIN) including those of the 6th year. Decentralization to any other Hospital outside of Santiago de Compostela is not possible for incoming students.
- The available clinical services are those indicated in each subject. When assigning clinical practices, the student's preferences will be taken into consideration, which does not guarantee a place in the preferred clinical service.
- The assignment of the internship service is carried out in the Faculty Secretary's Office. Once the learning agreement has been signed, each student must request the internship calendar that has been assigned to them at the following email address: medicina.uaxcd@usc.es
- It is recommended to have a fluent level of Spanish. To improve the level language, you can take courses at the USC Centre for Modern Languages https://www.usc.gal/en/center/centre-modern-languages
- Clinical Practice I G2051326 (3rd year): annual subject of 6 ECTS. In each semester the rotation period is fixed for each group (three groups). Students must complete a two-and-ahalf-week rotation each semester in one of the following hospital services with a vacant place: Allergology, Anesthesiology/ICU Conxo, Cardiology, Cardiac Surgery, Plastic Surgery, Thoracic Surgery, Vascular Surgery, General Surgery, Digestive, Endocrinology

- and Nutrition, Hematology, Internal Medicine, Nephrology, Oncology, Pneumology, Rheumatology, Traumatology and Urology.
- Exceptionally, a semester-long rotation with a single five-week rotation is permitted; it is not possible to do two rotations in one semester. If the stay is for one semester, a certificate of attendance will be issued, as the student does not meet the requirements for taking the exam (taking two rotations). The certificate of attendance must be obtained from the Dean's Office of the Faculty by submitting the internship completion report signed by the internship tutor.
- Clinical Practice II G2051426 (4th year): annual subject of 12 ECTS. In each semester the rotation period is fixed for each group (three groups). Students must do a five-week rotation in each semester in one of the following hospital services with a vacant place: Allergology, Anesthesiology/ICU Conxo, Anesthesiology and Resuscitation, Cardiology, Cardiac Surgery, Plastic Surgery, General Surgery, Digestive, Endocrinology and Nutrition, Hospital at Home, Hematology, Internal Medicine, Nephrology, Obstetrics and Gynecology, Oncology, Otorhinolaryngology, Pediatrics, Pneumology, Rheumatology, Traumatology, ICU, Urology and Emergencies.

Exceptionally, a semester-long rotation with a single five-week rotation is permitted; it is not possible to do two rotations in one semester. If the stay is for one semester, a certificate of attendance will be issued, as the student does not meet the requirements for taking the exam (taking two rotations). The certificate of attendance must be obtained from the Dean's Office of the Faculty by submitting the internship completion report signed by the internship tutor.

• Clinical Practice III G2051526 (5th year): annual subject of 12 ECTS. In each semester the rotation period is fixed for each group (three groups). Students must complete a five-week rotation in each semester, one rotation will be in a Health Centre and another in one of the following hospital services with a vacant place: Anesthesiology and Resuscitation, Cardiology, Cardiac Surgery, Plastic Surgery, Thoracic Surgery, Vascular Surgery, Dermatology, Nephrology, Neurosurgery, Neurology, Ophthalmology, Oncology, Pneumology, Traumatology, ICU, Urology and Emergency.

The rotation in Primary care health centre will outside of Santiago de Compostela, and the travel will be paid for by the student. This rotation may be replaced by a rotation in a hospital





service as long as there are vacancies, and in this case, there will be two hospital rotations. Exceptionally, a semester-long rotation with a single five-week rotation is permitted; it is not possible to do two rotations in one semester. If the stay is for one semester, a certificate of attendance will be issued, as the student does not meet the requirements for taking the exam (taking two rotations). The certificate of attendance must be obtained from the Dean's Office of the Faculty by submitting the internship completion report signed by the internship tutor.

Clinical Internship (6th year): only for incoming students of two semesters stay who prove that they have passed the basic and compulsory subjects of Medicine degree. It is not possible to include in the learning agreement subjects from the lower years with subjects from the 6th year; registration will be for the entire 6th year.
